1 Refers to pure leasing companies, defined as those companies whose principal activities are in leasing.

2 Refers to pure factoring companies, defined as those companies whose principal activities are in factoring.

3 Quarterly statistics refer to 24 pure leasing companies with outstanding lease receivables exceeding RM3 million (prior to December 1992, the quarterly statistics refer to only 28 pure leasing companies) and 8 pure factoring companies, while yearly statistics refer to 55 pure leasing companies and 15 pure factoring companies.

4 Leasing applies to leasing companies, whereas factoring applies to factoring companies.
