Data for 1999 and 2000 have also been reclassified based on the new methodology.

<sup>2/</sup> In accordance with the methodology set forth in the BPM5 of the IMF, data on issuance and redemption of bonds and notes by the official sector has been reclassified and recorded under portfolio investment from the first quarter of 2004.
