With effect from April 2006, following reclassifications under the Financial Institutions Statistical System (FISS), loans/financing by economic sector/industry encompasses non-household customers while loans by purpose encompasses loans to all customers. Therefore, a loan to a non-household customer will be reflected in both economic sector/industry and purpose.
NPLs by sector (economic sectors/industry + household sector) = NPLs by purpose (Total NPLs).

The breakdown by economic sectors/industries and purpose is not strictly comparable to the previous classification in Table III.20
